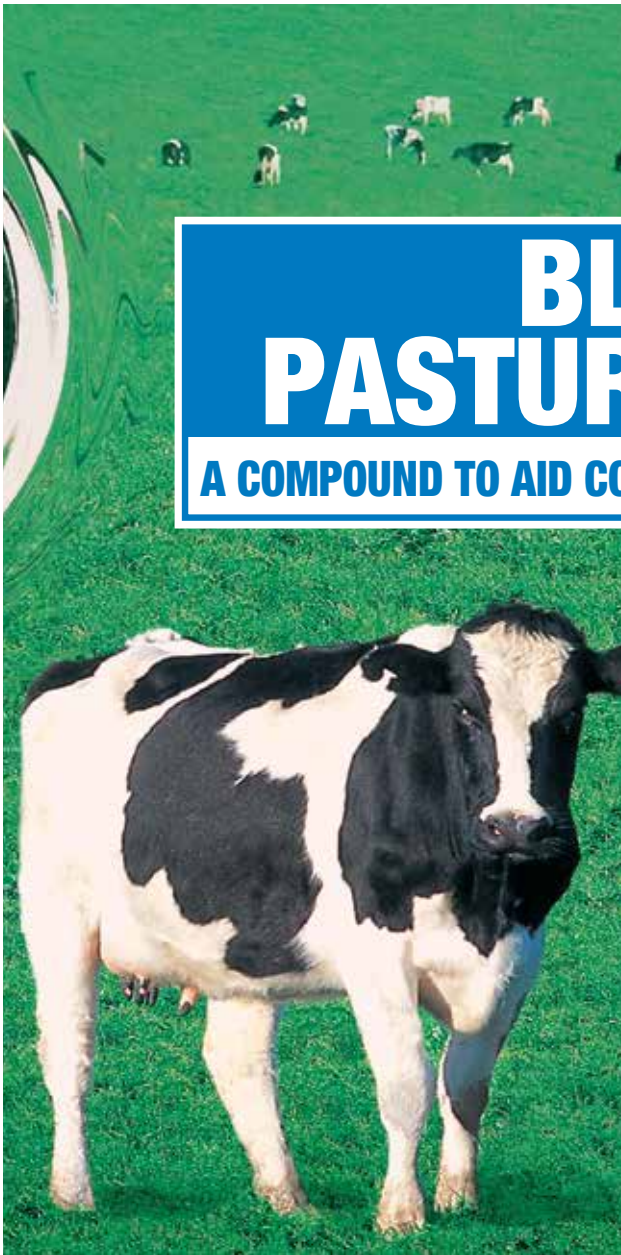

# BLOAT PASTURE SPRAY

A COMPOUND TO AID CONTROL OF BLOAT IN CATTLE

## DIRECTIONS FOR USE

**BLOAT PASTURE SPRAY is a highly refined miscible oil which forms an emulsion that is suitable for pasture spraying when mixed with water.**

### Spray Application Rates

Use 85 mls of BLOAT PASTURE SPRAY per cow per day, 4.5 litres will protect 50 cows per day. For typical grazing situations BLOAT PASTURE SPRAY can be made up as follows; mix 4.5 litres of BLOAT PASTURE SPRAY with 95 litres of water to cover the area to be grazed by 50 cows in one day. To ensure adequate penetration on pastures which have been idle and show heavy growth, the amount of BLOAT PASTURE SPRAY used may need to be greater than 4.5 litres in 95 litres of water. Conversely, less BLOAT PASTURE SPRAY than 4.5 litres per 95 litres of water may be required on paddocks with a lower animal feeding capacity.

### Drench Application

Use BLOAT PASTURE SPRAY **WITHOUT DILUTION** (Neat) as a drench at the rate of 113 mls per cow.

### Mixing

The spray tank should be half filled with water, then with the agitator operating the required quantity of BLOAT PASTURE SPRAY should be added to the tank followed by the remainder of the water. Recirculation should continue until completion of spraying. Emulsions that have been allowed to stand for any length of time may begin to separate. To re-emulsify the solution, recirculate through the pump or stir vigorously in the holding tank.

### Spraying

The use of a boom spray is recommended to ensure optimum coverage, penetration and minimise losses due to wind drift. BLOAT PASTURE SPRAY will wash off with heavy rain. Re-spraying is necessary as soon as possible.

### Grazing

Strip-grazing with the use of electric fences of the selected pasture will simplify the spraying requirements and thereby assist in controlling bloat. Ensure that all the selected pasture is adequately treated including those areas that can be reached outside the fence line. Avoid back-grazing as young shoots that are not treated are bloat inducing.
